



### BRIDAL INFORMATION AND CONTRACT

The purpose of this Agreement is to confirm the services to be rendered for the bridal party along with the name(s) of those responsible for payment of services provided by Salon DeSante. Once this Agreement has been completed and signed, the services are scheduled. Salon DeSante requires seven (7) calendar days notice of any cancellation(s) of appointments listed on this Contract. If, for any reason any member of the party does not show up for a scheduled appointment(s), and did not give the required 7 days notice, the party responsible for this contract will be held responsible for the payment in full of any such service(s).

A non-refundable deposit of 50% is required at this time. The balance will be required on the day of the services. The balance is subject to change due to adjustments upon completion of services.

All prices shown herein are estimated prices; any adjustments will be made upon completion of the service. You are responsible for changes and/or cancellations for all of your bridal party. **All changes must be made only through the Bridal Consultant only!**

For your convenience, it is strongly advised to wear a button-down shirt if hair or make-up will be done. In addition, anyone obtaining an up-do should have clean dry hair.

Please note: Trial runs for hair and make-up are optional, but based on our experience, these services are strongly recommended! Trials for both hair and make-up are priced separately and are not part of this contract. Take advantage of this appointment for your pre-bridal photos or rehearsal dinner.

Salon DeSante will provide complimentary pastries and refreshments on the morning of your Wedding Day.

This Agreement must be completed before scheduling of services.

I have read and understand the cancellation and refund policy. Any cancellations of scheduled appointments must be received 7 calendar days prior to the date of service.
